## 5.1.1 Species

## **Explanation on page 16 of Appendix 8.1 - Year 2 Avian Report**

The desk study identified records of five bird species within 5km of the Site that are listed on Annex 1 of the EU Birds Directive and 13 species that are listed on Schedule 1 of the Wildlife and Countryside Act 1981 (as amended). In addition, 28 BoCC red-listed species, 30 BoCC amber-listed species, 24 priority species listed in Section 7 of the Environment (Wales) Act 2016, and two species with dedicated species action plans on the Powys LBAP have been recorded within 5km of the Site in recent years. For the purposes of brevity, only species listed on Annex 1 and/or Schedule 1 are detailed in **Table 4**, below. A full species list can be found in the separate Ecological and Ornithological Desk Study (**Appendix 7.1**, Volume 3).
